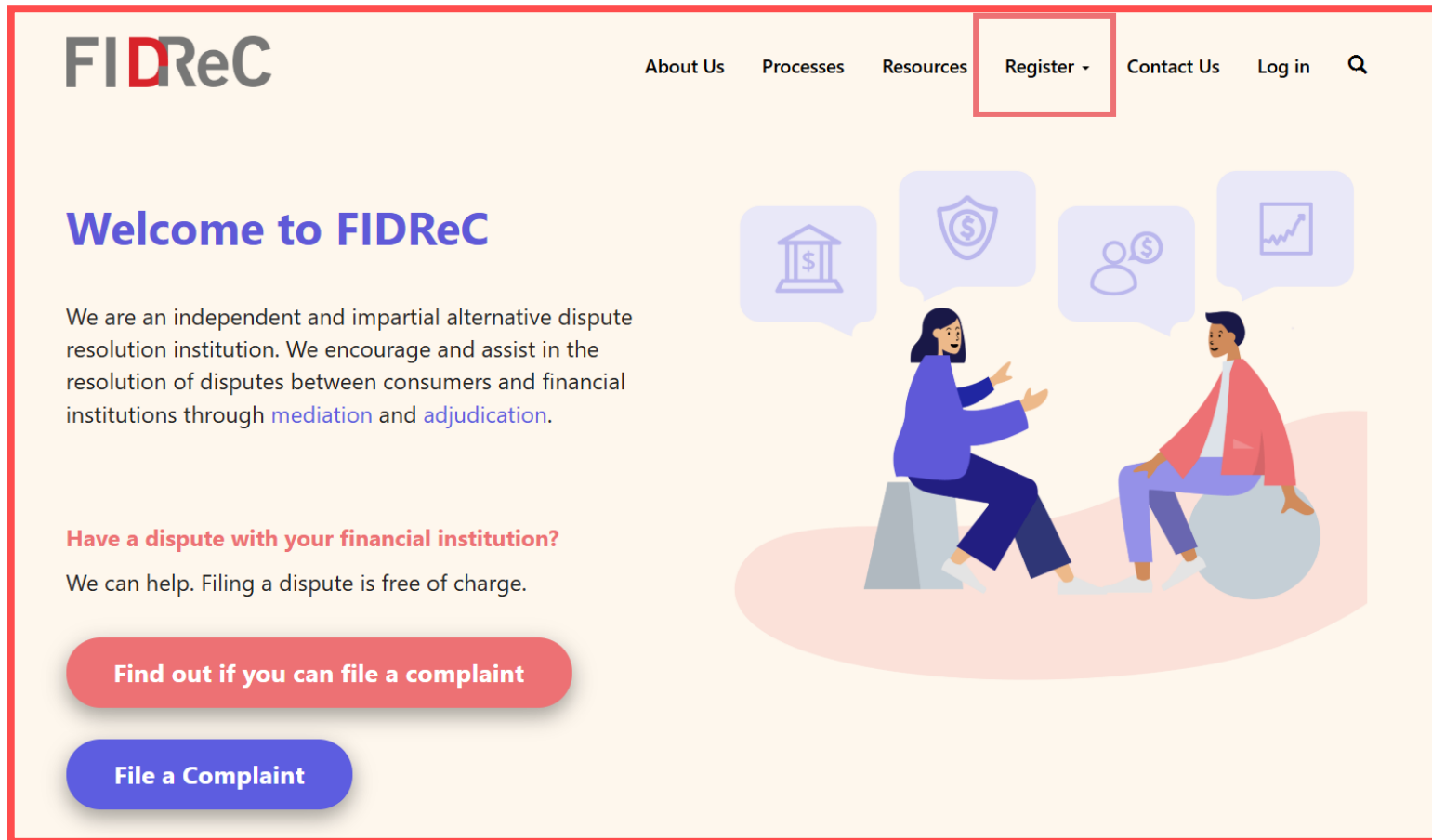

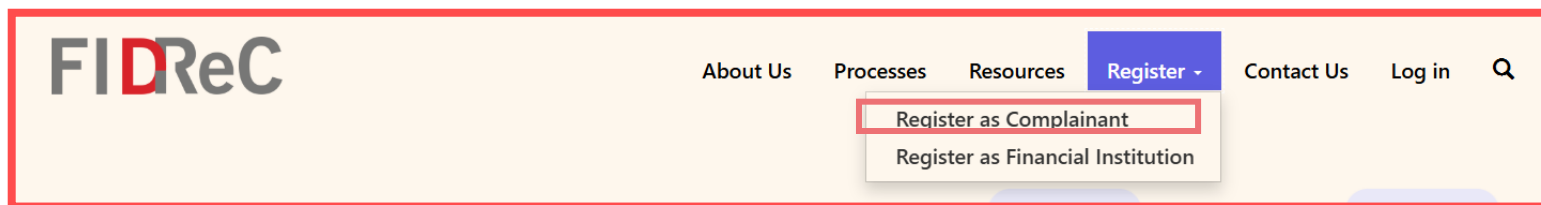


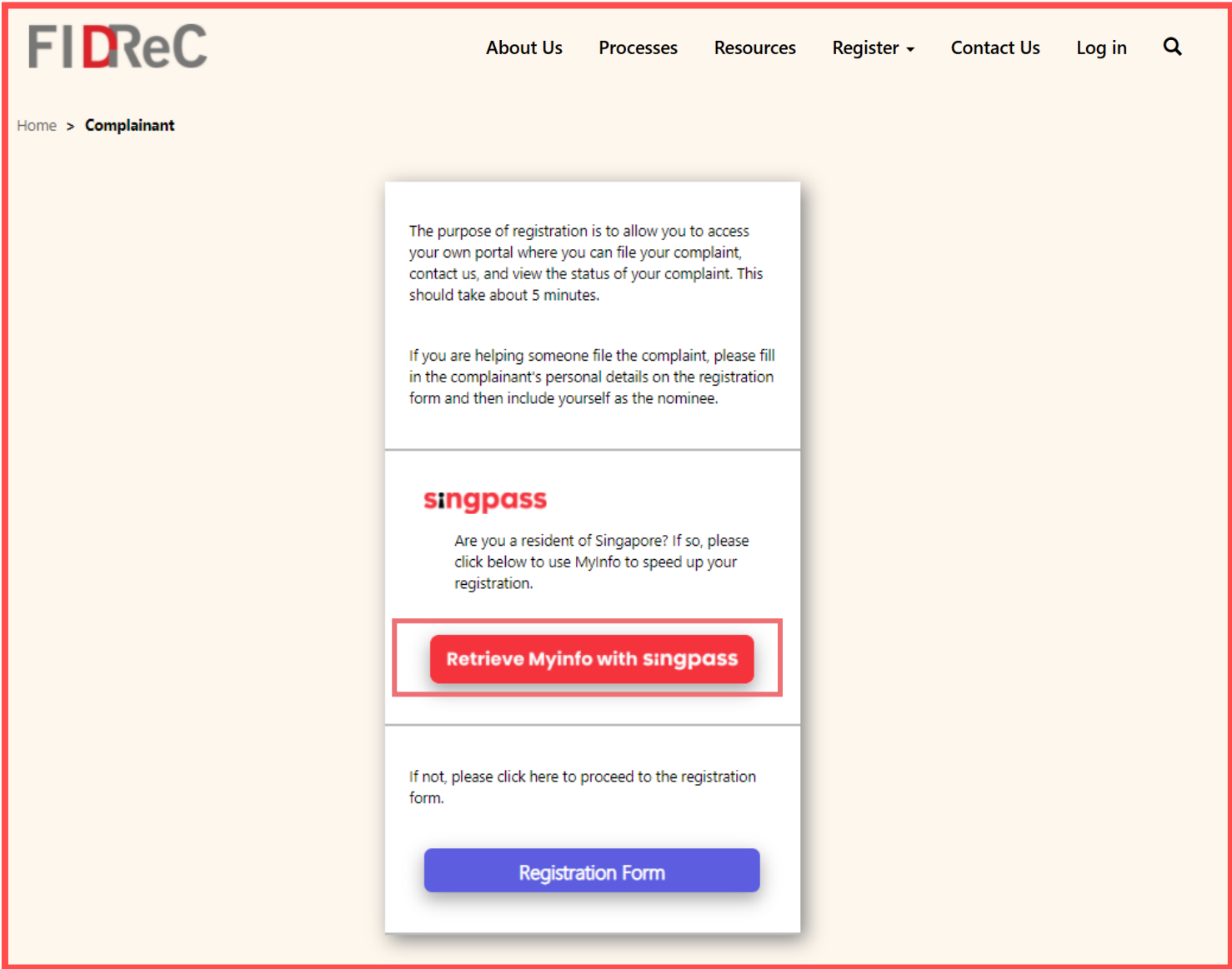

1 To register an account with us using our online form, select the **Register** option on the top menu, and click on **Register as Complainant**.





2 On the registration options page, select **Retrieve Myinfo with singpass**. This will bring you to the Singpass login page.

 **Some helpful tips:**  
If you do not have Singpass, you can register with us using our online **Registration Form**. You will have to fill in your details and FIDReC will authenticate your identity separately.

3 On the login page, Singpass offers two ways for you to log in. You can choose to use either the **Singpass app** or the **Password login**.

4 To login using the Singpass app, you can choose to scan the QR code with your app to authenticate your identity.

5 To login using the Password login, simply enter your Singpass ID and Password to log in.
